-----**I. Publishing of the Article**

Parties agree that after peer review and acceptance of the manuscript submitted by Author, Publisher will enable unrestricted Web access to the Article from the Publisher's website, in exchange for a fixed payment from the Author. Publisher will also publish the Article in the printed Journal.

**II. Rights and Obligations of Publisher**

By the execution of the present Agreement Publisher shall acquire a sole and exclusive license to the Article for the purpose as defined in Article I above. The Author shall, however, not transfer the ownership of his/her copyright related to the Article onto Publisher.

The Publisher's rights to the Article shall especially include:

- to make the Article freely accessible through the official Website of Publisher on-line for an unrestricted period of time
- to publish the Article in the printed Journals as listed on the official Website of Publisher
- to quote from the Article on the official Website of the Publisher and to make the Title and the brief introduction of the Article accessible through search engines on the Web
- to take measures on behalf of the Author against infringement, inappropriate use of the Article, libel or plagiarism.

The Publisher shall ensure

- the Author to be identified as the author and owner of the copyright of the Article
- maintaining the integrity of the Article once refereed and accepted for publication.

**III. Rights and Obligations of Author**

The Author declares and warrants that he/she is the exclusive author of the Article or has the right to represent all co-authors of the Article respectively and has the right therefore to enter into the present Agreement and entitle the Publisher the use of the Article subject to the present Agreement.

All other rights except as described in Article II hereto are retained by Author. Author therefore shall especially have the right to

- publish the Article on his/her own website
- transform, translate, extend or abbreviate the Article
- to quote from the Article
- to grant license to the use of the Article by any third party.

The Author expressly acknowledges and accepts that he/she shall be entitled to no royalty (or any other fee) related to any use of the Article subject to the present Agreement.

**IV. Re-use of Third Party Content as Part of the Article**

Should Author wish to reuse material sourced from third parties such as other copyright holders, publishers, authors, etc. as part of the Article the responsibility for acquiring and clearing of the third party permissions for such use before submitting the Article to the Publisher for acceptance.

Author shall hold Publisher harmless from all third party claims in connection to the unauthorized use of any material under legal protection forming a part of the Article.

**V. Publishing Fee**

The Publishing Fee shall be 900 EUR (1125 USD) + VAT where applicable. Author shall transfer the Publishing Fee to the bank account of Publisher indicated on the invoice issued by the Publisher.

Publisher offers 50% discount of the above Fee for authors a) with a live subscription of the journal and authors of b) subscribing institutions, c) Hungarian institutions, d) institutions of low- and lower-middle-income countries. Discounts may not be combined, all these authors should pay 450 EUR (562 USD) + VAT where applicable. Please sign the Discount Form and send it to the Publisher.

The obligations of Publisher under this Agreement shall only be binding when the Publishing Fee has been credited to the bank account of Publisher.

**VI. Previously Published Articles**

When the Article has previously been published by Publisher subject to the Copyright Transfer Agreement between Author and Publisher the provisions of the present Agreement shall be applicable to the rights and obligations of the Parties regarding the use of the Article during the validity of the present Agreement.

**VII. Other Provisions**

Subject to the present Agreement the Article shall be deemed as first published within the Area of the Hungarian Republic. Therefore the provisions of the Hungarian law, especially the provisions of Act LXXVI of 1999 on Copy Rights shall apply to the rights of the Parties with respect to the Article.

For any disputes arising from or in connection with the present Agreement Parties agree in the exclusive competence of the Central District Court of Pest or the Capital Court of Budapest respectively. This Agreement shall become valid after execution by both Parties.
